- Proceedings are hereby initiated for the formation of a general improvement district pursuant to Chapter 318, Title 25, of the Nevada Revised Statutes.
- 2. The name of the proposed district will be Gardnerville Ranchos General Improvement District.
- 3. The general purposes for which the district is proposed to be formed are for grading, paving, curbs, gutters, sidewalks, storm drainage, sanitary sewer improvements, water improvements, street lighting, and garbage and refuse collection and disposal.
- 4. The boundaries of the proposed District and the territory to be included therein is described in Exhibit "A" hereto attached and by reference made a part hereof.
- 5. The lands within the proposed district are within seven miles from the boundaries of the unincorporated Town of Minden and the unincorporated Town of Gardnerville. Petitions for the annexation to and inclusion of said lands within said Towns have been filed with the governing body of said Towns pursuant to law and the governing body thereof has refused to annex or include said lands and has entered the fact of such refusal in its minutes.
