**District Counsel Report:** David Rigdon reviewed his memorandum regarding the Bing Pit Purchase – Due Diligence Timeline with the Board and Staff.

Pursuant to the terms of the contract, escrow has been opened and the 120-day due diligence period has now started. Unless extended by agreement of the parties, the 120-day due diligence period will end on December 16, 2025. At that point the district's \$25,000 deposit becomes non-refundable. Closing is scheduled to occur on January 15, 2025. The GRGID will need to have the \$2,475,000 of the remaining down payment deposited into escrow by that date.
